## THE HOTELS (INCENTIVES) ACT, 1968 (Act 16 of 1968)

THE APPROVED HOTEL ENTERPRISE (MONTEGO TOWERS HOTEL ENTERPRISE)
ORDER, 1969

In exercise of the power conferred upon the Minister by section 3 of the Hotels (Incentives) Act, 1968, the following Order is hereby made:—

- 1. This Order may be cited as the Approved Hotel Enterprise (Montego Towers Hotel Enterprise) Order, 1969, and shall have effect on the day appointed by the Minister for the coming into operation of the Registration (Strata Titles) Act, 1968.
- 2. The Montego Towers Hotel Enterprise which relates to a hotel proposed to be established at Montego Freeport, Montego Bay, in the parish of Saint James, is hereby declared, pursuant to an application made by Montego Towers Development Corporation Limited and dated the 17th day of December, 1968, to be an approved enterprise.
- 3. The date on which the operation of the aforesaid hotel shall commence for the purposes of the Act shall be the 1st day of November, 1970.

### THE IRRIGATION LAW (Cap. 168)

THE HOUNSLOW (IRRIGATION AREA) ORDER, 1968

In exercise of the powers conferred upon the Minister by section 3 of the Irrigation Law and of every other power hereunto enabling, the following Order is hereby made:—

- 1. This Order may be cited as the Hounslow (Irrigation Area) Order, 1968.
- 2. The area described in the Schedule to this Order is hereby declared to be an irrigation area for the purposes of the Irrigation Law.

#### SCHEDULE

#### Hounslow Irrigation Scheme Limits

Commencing at the intersection of the northern boundary of the main road leading from Williamsfield to Pedro Cross and the eastern boundary of Parochial Road No. 3 leading from Kildare to Watchwell; thence generally south-easterly along the northern boundary of the aforesaid main road to its intersection with the western boundary of Parochial Road No. 37 leading from Geneva to Industry Pen; thence generally northerly, easterly, north-

westerly and generally north-easterly along the western boundary of the said Parochial Road to its intersection with the western boundary of Parochial Road No. 25 leading from Big Woods to Malbern Well; thence generally north-westerly along the western boundary of Parochial Road No. 25 to its intersection with the northern boundary of Hounslow Property; thence westerly in a straight line along the northern boundary of Hounslow to the north-western corner of the said property, and continuing in the same straight line to its intersection with the eastern boundary of the aforesaid Parochial Road No 3; thence generally southerly along the eastern boundary of the said Parochial Road back to the starting point.
